General Terms and Conditions of the Exhibition

Updated June 2020

1. Registration requirements

Registration for the digital exhibition is only possible by using the official registration form on the event website, which must be completed and sent in a legally binding manner. With the written registration, the exhibitor acknowledges the exhibition conditions of the organizer in all parts. In the event of violations, the organizer reserves the right to exclude exhibitors from the exhibition in the future.

2. Rental of the digital exhibition booth

The exhibitor will receive an automatic confirmation of receipt from the organizer after receiving his registration. The final confirmation with further documents will be given by the organizer right after registration.

3. Booth design

The exhibitor undertakes to submit all content and files relating to the booth design to the organizer on time.

4. Termination of contract

Exhibitors who are registered and have received the written approval from the organizer can be released from the contractual relationship free of charge until July 31st of the event year. After this date, regardless of proof of damage from the organizer, the exhibitor owes payment of 35% of the stand fee. After August 1st of the year of the event, regardless of proof of damage by the organizer, the exhibitor owes the payment of 100% of the booth fee.

5. Terms of payment

The exhibitor is obliged to transfer the total fee to the organizer no later than 14 days after invoicing. If the invoice is not paid or not paid in full, the organizer is entitled to deny the exhibitor access to the digital event. In the event of late payment, default interest of 2% above the current base rate of the Bundesbank is payable.

6. Registration of the included free participant

Registration of the free participant included in the exhibition booking must be made by August 15th of the event year.
